As we swing into summer, some of the boating and social restrictions have eased. Maryland guidelines now allow recreational vessels to go out, but only with family and

people who live together. The "stay at home "order has been lifted across Maryland, but some counties are extending it. The City of Annapolis just announced that retail stores may open, but only one customer at a time. This is clearly confusing and SOS has members across several states and multiple counties; whiplash anyone?

To help the SOS Board and committee chairs make plans in this difficult environment, we need input from our members. In early May, a survey of SOS skippers was done. Not surprisingly, many boats were still being readied for the season, and some skippers were not planning to take on any crew this summer. But there are skippers who plan to sail and to take crew; they will be following safety related protocols. Read the 2020 SOS Cruising Plan on Page 5 in this newsletter and sign up online if you wish to be considered for crew. At this time there will be no cruising coordination.

You will already have received a member survey asking you about your willingness to sail as crew this summer, and to attend an SOS social event. This input is critical as we decide, once Maryland rules permit, how and when to restart our social events. First up is the June 27 Anniversary Party. As of May 16, no final decision has been made about this event. Once an event is offered, you may be sure it will be outside and that both Maryland and CDC guidelines are followed. One of the events we cancelled was the General Membership Meeting scheduled for May 31. In order to comply with club bylaws, this meeting will be held on June 11 via Zoom. In addition to the usual committee reports, there will be potential bylaw amendments to discuss. One amendment deals with holding SOS meetings electronically and one deals with the restructuring of member dues.

The Education Committee has been churning and burning and are putting out some cool virtual education programs and games. There are also a number of virtual happy hours occurring plus a page of sailing-themed movies is on the club website. Watch a movie, start a virtual happy hour, or get involved in online education programs, no need to be bored!

Stay tuned as we slowly plan to begin offering some limited social events and sailing. Let's be optimistic that the virus situation will continue to resolve. I can't see you on the water, but I'll see you on

This is for your information and not a club policy change at this time.

## Notice of General Membership Meeting June 11<sup>th</sup>

All members are invited to attend a Virtual General Membership meeting on June 11, 2020 via ZOOM.

As directed by our bylaws, the Treasurer will provide a budget update and overview, and each committee chair and/or their board liaison will share a summary of the 2019 year's highlights and a look ahead to 2020.

The minutes from the previous General Membership meeting held at the Annual Town Hall in Galesville on August 11, 2019 will need approval. Minutes are on page four for your review.

## **Major Changes Considered for Membership Dues**

Your Board of Directors is considering some changes to the dues structure of SOS. There are several reasons for considering change.

We are now in a situation where over 40% of SOS members are designated as Lifetime members and pay no dues. This is likely to place a financial strain on the club and place a financial burden on those members not eligible to become Lifetime members. Club leaders foresaw this situation more than a decade ago and placed a limit on the number of Lifetime members by making such designation contingent on: a) having joined the club by 3/31/2009 and b) having at least 10 years of membership.

Even with the stop date, there are more than 60 current members who ioined the club before March of 2009 and will be reaching the required age of 70 in the not-too-distant future. Unless we add a significant number of new members, the proportion of non-dues paying members will continue to rise and will eventually become more than 50% of the SOS club membership. Financial modeling projects that if no changes are made to the current dues structure, and assuming that annual club administrative expenses remain the same, shortfalls will begin this fiscal year and increase every year going forward. These shortfalls will require drawdown from club reserves to cover operating expenses. In this

scenario, annual budget shortfalls will exceed \$5900 by 2029 and club reserves will be greatly reduced, reaching \$0 by 2034.

In addition to the fiscal strain on the club, there is federal tax law which applies to SOS. There is an IRS ruling, applying to social clubs, that says you cannot have different classes of membership, such that one class pays substantially more in dues while both (all) classes receive identical benefits. Although it is highly unlikely that the IRS will come looking at the SOS dues structure, it is also ethically and fiscally responsible to avoid a legal risk to the club's non-profit status.

In view of these issues, the BOD has approved an ad hoc committee, chaired by Lorraine Fassett, to review the fiscal and legal constraints. Our goal is to develop several options for change to the current dues structure. We plan to ask for input from club members before continuing to a final recommendation. Before any change is made to the dues situation of Lifetime members, there would need to be a bylaw change. Several options for a bylaw change will be offered for member discussion and input. A final option will be presented for a vote at the August Town Hall Meeting.

#### "A Dinghy Perspective: BOD Meeting Highlights" May 7, 2020 Board Meeting Compiled by Sharon Taylor

**Commodore:** Due to Covid-19 meeting restrictions, the spring general membership meeting may be held via Zoom. If so, members will receive SOS officer and committee chair reports at least 10 days before the meeting. Members should submit any questions to the Commodore at least five days before the meeting.

To be discussed at the meeting are proposed Bylaws amendments addressing: 1) member dues restructuring, and 2) remote electronic voting and attendance by SOS Board and general members.

**Treasurer**: The club received no revenue for April. Even though expenses were lower due to cancelation of club events, the club still must pay fixed expenses, such as insurance, website, and storage lockers. Issues in reconciling expenses and revenue accounts on the new website are delaying the scheduling of the audit.

**Secretary:** Board meeting minutes for October 2019-February 2020 meetings have been sent to the database for posting to the website. In process is a separate file for approved BOD motions to facilitate searching of past Board actions.

Bareboat: The canal trip is on hold. Final decisions in June.

Brunch: The May 31 brunch has been cancelled.

**Cruising:** Consistent with the Governor's social distancing orders, May and June events are canceled, with the exception of the June 27 Anniversary Cruise, which may be able to proceed with correct social distancing. SOS will not collect funds for cruises or assign crew while the Governor's order remains in place. When his order changes, SOS will re-evaluate the situation. SOS is considering offering on-line courses and events.

**Database:** Current membership: <u>467</u>: 391 members; 76 skippers.

**Education:** An on-line training program, "Off the Dock," is in the making. Sandy Huberfeld offered to do an activity that would be open to Club Members. She explained that since the sailing season wasn't going to be as usual her goal was to offer an activity available soon that would be nautically oriented and fun for members to enjoy. Several board members mentioned possibilities including a nautical "Jeopardy" Game which was created by Andy Katz and Jean Wintemute that was warmly received at the April Northern Virginia Happy Hour (via Zoom). Sandy was given approval to proceed with activity tbd.

First Mates: The June 6 First Mates' meeting is cancelled.

**Membership**: Underway is a "Benefits of Being a Skipper" list. A suggestion consistent with the times: Member face masks with the SOS logo. The Board passed a motion to include an acknowledgement in the SOS membership application and in the on-line membership renewal indicating receipt of, and agreement with, SOS's harassment policy.

**Policies & Procedures sub-committee:** The Board is considering a bylaw change to allow electronic access to Board and general membership meetings.

**Public Relations**: Bev Wright, a skipper member, has volunteered to help with the committee. The Board passed a motion to pay the Meet-up fee of \$200/year.

Safety: Nothing new to report.

Skippers' Advisory: Nothing new to report.

**Social:** The June 27 Anniversary Party remains uncertain due to social distancing requirements.

## **Fleet Exercises and Shore Leave**

## No SOS cruising coordination will take place until we are in Phase III of Governor Hogan's COVID-19 Recovery Plan.

## Below is the 2020 SOS Cruising Plan:

1. No typical cruising coordination will take place until we are in Gov. Hogan's Phase III. This keeps the club out of the position of suggesting specific crew for any skippers.

2. A survey of members will be sent to determine who is ready to go sailing this summer (willing to be crew) and under what conditions. We will also ask about willingness to attend parties and meetings, etc.

3. A list of members who are willing to sail this summer will be developed. Members who wish to be invited to crew may post their names on a club website page, or on the members "io" group. (No non-familial crew may be invited until MD boating rules are changed).

4. The existing framework of both Day and Weekend sails and destinations will be retained. There will be no event specific coordination. Cruises and destinations can be posted on the skippers "io" group or other platform in addition to remaining in the Whisker Pole.

5. Skippers may invite known crew or crew from the list of available members. Skippers may coordinate sailing to specific locations, but there will be no rafting.

6. The first cruise-related party (June 27-28) remains on the calendar. Cancellation depends upon social distancing guidelines in June. More information coming on this, as your social committee is planning for a potential outdoor party with social distancing.

We understand that this will not be helpful to new members and to many long-time members who do not own boats but want to get out on the water. However, we do not want to encourage situations which could lead to transfer of illness among our members or increase liability for the club. As boating and social distancing guidelines change, these guidelines will be modified as well.

The member survey will go out very soon. Meanwhile, if you wish to be considered for a crew position on an SOS boat this summer, please contact John McDonald (dbchair.sos.org@gmail.com) who will place your name on the list of available crew. Remember that until Maryland guidelines change, no crew other than family or those who live together may be on a boat together.

**No fees** will be assessed for any sailing activities until Maryland goes into Phase II and allowing larger groups and less social distancing. However, skippers may ask their crew to complete and sign the sailing registration form which can be found online.
